ONE LIBERTY PROPERTIES ACQUIRES INDUSTRIAL PROPERTY

- Company has Added Over \$38 Million of Properties in 2018 -

GREAT NECK, New York, November 1, 2018 — One Liberty Properties, Inc. (NYSE: OLP), announced that it acquired a 64,000 square foot industrial property on 5.19 acres located in Moorestown, New Jersey, a suburb of Philadelphia, Pennsylvania, for \$7.4 million. The building is net leased through early 2028 for an aggregate annual base rent of approximately \$531,000, increasing annually, beginning in 2020, by \$16,000.

The facility is used for warehouse and distribution purposes and has easy access to major transportation thoroughfares including I-95. The tenant, Xerimis, Inc., provides clinical packaging, distribution, and labeling services to the pharmaceutical, biotech and clinical research organizations globally. Xerimis has been at this location since 2000 and in 2017, extended their lease until early 2028.
